


One Year and Counting...

For over a year life has been dominated by one tiny virus. It has caused upheaval in every day life and brought tragedy to countless families. When will we have control over this unseen menace? The answer to that is best left to the experts. In the meantime, the Board of Directors and staff of Rocky Mountain Rural Health (RMRH) continue in our mission to improve the physical and mental health of Park County residents. We've adopted a two-prong approach to alleviate the effects of the COVID crisis.

One of these efforts is designed to assist residents facing financial difficulties due to COVID related situations and the other is to assist in vaccination efforts. With the support of the Town of Fairplay, the Town of Alma, The



Summit Foundation and the Brown Family Foundation, we have assisted over 150 people with utility bills, rent, gas and groceries with over \$15,000 paid toward these everyday necessities of life. If you, or someone you know is suffer-

The other effort takes a different approach to alleviating the effects of COVID. Ever been near the Fairplay Post Office on a Wednesday? Then you may have wondered what is going on next door at the doctor's office, South Park Health Care. Lots of traffic and people sitting in their parked cars. What are they doing? Filling out paperwork and waiting their turn to go into the doctor's office to receive a COVID vaccination!

In partnership with Park County Public Health, the South

Park Health Service District, and faithful volunteers, we have assisted in the weekly vaccination clinics in Fairplay. As of this writing, over 2000 vaccinations have been administered at this clinic and that number grows every week.

Connect for Health Colorado® Extends Enrollment Period through at least August 15

THE TIMES THEY ARE A-CHANGIN'...we've added something else to our social distancing, hand washing, mask wearing daily routine. It is called:

VACCINATION CLINIC ETIQUETTE

DO:

Wear a mask Not every county is 'Green'; people being vaccinated are from all over Colorado and the US; masks reduce the risk of infection to you and others

Arrive on time The vaccine you receive is time sensitive; having late arrivals puts the carefully orchestrated schedule in danger of going longer than the vaccine is viable

Follow instructions Clinic personnel will be strategically placed to make sure everyone will be able to complete the process in a safe, socially distanced manner

Come prepared To complete paper work with health history and to wait at least 15 minutes after receiving your vaccination to make sure you do not have a reaction

DON'T:

Double Book Bad idea! Vaccine is thawed out for you at each clinic you've scheduled at. The clinics you No Show at must find some one last minute to take your place or risk wasting precious vaccine.

No Show Don't trust PreMod to record your online cancellation. Call the Agency that is running the Vaccination Clinic to tell them you are not coming. See 'Don't Double Book'.



Covid Q&A

'Health Matters' recently posed some frequently asked questions to a local health care provider. Here is what we learned.

- Q. How long have mRNA vaccines such as Moderna and Pfizer and adenovirus vector vaccines such as Janssen (Johnson & Johnson) been in research, development, and testing? A. The mRNA vaccines have been used since the 1990's and in animal models have proven effective against flu, Zika virus, and rabies. The adenovirus vector vaccines have been around since the 1970's and is the platform used over the last two decades as an Ebola vaccine.
- Q. Why do some people have a stronger response to the second shot of the vaccine than the first shot? A. After the first dose (or after having had a COVID infection), the person has existing antibodies. These are activated with the second dose of vaccine (or sometimes after the first dose if the person already had COVID) which can cause more significant symptoms. This is the immune system responding to the vaccine and does not mean there is an infection.
- Q. If I get the vaccine, will it effect any future children I might have? A. The mRNA in the vaccine is destroyed by the person's metabolism and cannot be passed on to future children. Antibodies made by the mother cross the placenta into the baby giving them temporary immunity. We do know that babies born after their mothers have been vaccinated may have antibodies to COVID-19.
- Q. Will I need to get a vaccine every year like the flu shot? A. The Center for Disease Control (CDC) and vaccine manufacturers as well as most Infectious Disease experts believe that boosters/yearly vaccinations will be needed because of the virus's ability to mutate into different strains (variants).



Q. What if I lose my card proving I got vaccinated? A. Every vaccine administered is recorded by the local public health department and with Colorado Department of Health and Environment (CDPHE). Proof of getting the vaccine can be requested from those offices.

- Q. Is herd immunity a real thing? A. Herd immunity refers to the phenomenon where a virus spread is limited by the low number of susceptible individuals in the population. If a person has an infectious disease but is surrounded by immune individuals, then there is no place for the virus to go. This makes it less likely that a non-immune person will encounter the virus and so is not likely to get sick with it.
- Q. How does mass vaccination affect herd immunity? A. The percent of people immune to a disease to achieve herd immunity depends on the level of infectivity of the virus. For example, each person with SARS-CoV-2 is likely to infect 2-4 other people in the non-immune population. To achieve herd immunity, some experts say 50-70% (other experts say 75-80%) of the popula-

tion needs to be vaccinated or immune through having had COVID. In comparison, measles has much higher infectivity. Each person who catches the disease is expected to infect up to 15 other people in a non-immune population. To achieve herd immunity for measles, greater than 90% of the population needs to be vaccinated.
